

RFP for the Greater Victoria Coalition to End Homelessness' Speakers Bureau training session on stigma

TRAINING DESCRIPTION

The Greater Victoria Coalition to End Homelessness (the Coalition) requests a proposal to deliver training for its Speakers Bureau, concerning the various types of stigmas that individuals who have experienced homelessness and/or extreme poverty may have faced as well as building skills in challenging these stigmas.

ABOUT THE SPEAKERS BUREAU

The Speakers Bureau is a group of individuals who have experienced homelessness and want to share their story. Through funding provided by the United Way, the Coalition has provided training for these individuals to speak publicly about their personal experiences – putting a face to homelessness. Our speakers address a variety of issues including racism, mental illness, addiction, domestic violence, disability issues, and unemployment. In addition to the problems surrounding homelessness in Greater Victoria, our speakers will also discuss the solutions and their personal successes.

TRAINING DETAILS

Our speakers have identified that the main goal of this project is to address stereotypes associated with living in homelessness. They have also identified that they want to be careful not to perpetuate stigma and stereotypes against specific communities within the population of those that experience homelessness, such as those that use illicit substances. They wish to gain a broader understanding of the experiences that marginalized groups within the diverse population of those experiencing homelessness face, as well as learn how to better challenge perceptions about those experiencing homelessness and/or extreme poverty.

The speakers have diverse backgrounds. The Coalition would like to provide them with an opportunity to learn how to address stigma and build upon their skills in sharing their lived experiences without compromising their safety, privacy, or personal wellbeing.

Please provide a quote on training sessions and training materials, and a detailed timeline. Training sessions in the past have typically been for 0.5 days, over 1-3 days. Training should not exceed \$2000.

Please note that the members of the Speakers Bureau are paid honoraria for their time spent in training. They are also provided with food and bus tickets for every meeting. The Social Inclusion Coordinator will provide these components associated with training.

The Coalition values the input of individuals who have lived experience, and thus will privilege those who apply that have lived experience of homelessness.

Proponents will be scored on the following items:

- experience providing training to individuals with lived experience of homelessness and/or extreme poverty;
- experience providing community education on stigma;
- proximity to the Capital Regional District
