### Request for Quote: Human Resources Policy Review and Update

### **PROJECT DESCRIPTION**

The Greater Victoria Coalition to End Homelessness (the Coalition) requests a quote for review and update of its organizational policy manual.

The proposed work is to take place in two phases:

- Phase 1 detailed analysis of the current policies to identify gaps and required enhancements.
- Phase 2 work collaboratively with Coalition Staff to draft a series of new or enhancements to existing policies and procedures for review and approval by the Coalition Board of Directors Policy and Governance Committee.

The Consultant will review existing policies against current legislation and trends in governance, operations, human resources management, financial management and general administration recommending adjustments as appropriate.

### **PROJECT OBJECTIVES**

The objective of this policy review and update is to enhance the effectiveness and clarity in how the Coalition operates and conducts its day-to-day business. The following activities will be performed by the successful proponent:

- 1. Conduct a detailed review of the Coalition's current policy manual;
- 2. Prepare a brief report containing recommendations and rationale for improvements and/or enhancements;
- 3. Prepare draft updated version of the policy manual based on direction provided by the Coalition's Executive Director in response to the recommendation report;
- 4. Attend one meeting with the Coalition's Governance and Policy Committee to present the draft policy manual and seek input and guidance on final document; and,
- 5. Produce an updated version of the policy manuals.
