JOB SUMMARY

Specialized Youth Housing Support Worker

This position supports the work of the Lighthouse and reports to the Youth Supportive Housing Site Manager. This position is responsible for Work with residents and Youth Leadership Team to co-create a safe, welcoming, and calming environment for the individuals entering and living within the site.

Specific Responsibilities:

- Stay observant of the environment and provide intervention as required to ensure the safety and wellbeing of everyone.
- Discusses problem situations and remedies with site manager and lead workers. Participate directly in the resolution difficult or sensitive issues or problems.
- Collaborate with youth team in the development and implementation of youth support housing model according of Participatory Action Research principles and approaches.
- Organize activities related to your specialization and participate in other programs alongside youth.
- Provide first response to crisis intervention as required and personal safety allows.
- Performs other related duties as required.

- Experience working in high-stress environments where multitasking is required, or experience providing social support/mentorship.

Must meet some or all of the following:

- Experience working with street communities in housing, drop in or shelter settings.
- Experience in teaching or coaching social skills and activities of daily life in a group setting.
- Experience in discussing stigmatized subjects with youth.
- Knowledge of sexual health, social/life skills, mental health disorders and mental wellness, substance use/addictions, harm reduction, safety, disabilities, and cultural care.

- Knowledge of local community resources and service providers in the Greater Victoria area and of the social issues surrounding homelessness.
- Ability to problem solve and deal with conflict effectively and to set boundaries with others

GENERAL REQUIREMENTS

- This position requires flexibility regarding hours, as the site will be staffed 24/7
- This position is hiring for 7pm to 7am shifts evenings and weekends
- Must be comfortable working independently and as a part of a team.
- Must review and sign all agreements at the start of employment and follow the GVCEH's policies and procedures and orientation manual.
- Maintains knowledge of laws and legislation which affect our inner city family; Mental Health, MiSDPR, Bylaws, Human Rights, and health orders during COVID-19.

ADDITIONAL INFORMATION

This position is a part of a youth-led initiative to co-create an ideal housing situation based around co-operative living, skill building, and social enterprise. As such, the Youth Leadership Team of the project has identified the following as aspects of an ideal candidate:
